



## **RULES OF THE VI ELX INTERNATIONAL THEATER FESTIVAL 2023**

- 1.- The 6th Elx International Theater Festival will hold three official shows on the 2nd, 3rd and 4th August (the full festival will be from 1st to 6th August).
- 2.- Interested groups must fill the registration form in that follows the hereby rules and send it together with the required documentation to the following e-mail: [info@fitelx.es](mailto:info@fitelx.es)
- 3.- The deadline for proposals ends on 18th May 2023 and will not be extended.
- 4.- On 22nd May, the organizing committee of the Festival will announce the groups that have been selected.
- 5.- Given the international nature of this Festival, priority will be given to those plays that, due to their dramaturgical characteristics, can be well understood regardless of the language used in the interpretation. The festival is open to any dance-theatre, gestural theatre, street theatre and family theatre proposals.
- 6.- The artistic commission will select a maximum of 6 companies among all the applications received.
- 7.- The selected groups will receive a cache of € 1,000 on the condition that they stay at least two nights at the festival and thus be able to join and enjoy the other participating groups shows. The festival will take care of the mid-day meals, which will be shared.
- 8.- The companies will represent the same show that they have presented in the video, both regarding the number of actors and the scenery.
- 9.- In order to contribute to a good and due promotion of the Festival, companies must be willing to participate in all those promotion activities that the organization deems necessary.
- 10.- The Elx International Festival is a space to exchange ideas and thoughts, for learning about other theatrical realities. For this reason, the groups are expected to participate in the life of the city and in the parallel activities that take place offstage.
- 11.- Any circumstance that may arise and that may not be forecasted in these rules will be resolved by the organizing committee.

12.- Participation in the Elx International Theatre Festival implies acceptance of these rules. The Festival management is empowered to resolve incidents that occur in the development of this call.
